You could be eligible for free uniform for your child!

Dear Parents/Carers,

There is an additional 15 hours of funding per week available to some pupils who attend our school whose parents work, full or part-time.

Pike Fold Community Primary school already currently supplies all children in Nursery with a full time place, at no extra cost to the parents, however due to the increasing amount of budget cuts schools face we may not be able to continue to do this.

You could help us to be able to preserve this service to parents like yourselves if you check your eligibility against the below criteria, and if eligible please ensure you **apply for the additional hours** payback to school, using the link provided, and provide us with your 11 digit code as soon as possible..

You, and any partner, must each expect to earn (on average) at least £120 a week (equal to 16 hours at the National Minimum or Living Wage). If you, or your partner, are on maternity, paternity or adoption leave, or you're unable to work because you are disabled or have caring responsibilities, you could still be eligible.

You can't get free child care if you, or your partner, expect to earn £100,000 or more.

Once you have returned your active 11 digit code to us on the consent form supplied we will supply you with **one free Jumper/Cardigan/polo shirt/book bag for the child listed on the claim.**
